Lobbyist have been successful in having the Illinois Legislatue pass revised statutes to empower a State regulatory board to discipline it's subjects to and for the following reasons. This legislation known as House Bill 1015 is awaiting the signature of Gov. Pat Quinn - HB 1015 will not become law until Quinn signs the bill. You may read the part of the bill that pertains to mental health and chronically ill persons under the domain of this agency.

Please take the time to read the excerpt below. The bill

does not allow parity with other professional boards within the state that allows the member an "inactive status" for recovery, medication, consultation or review by a physician or psychiatrist before an arbitary decision is made by the disciplinary committee as to whether the person may continue in the practice of their profession and livlihood - the person is at the mercy of the disciplinary board of lay persons. At least the creation of an "inactive status" will allow a person to get their things in order. If you feel HB1015 is adequate and does no harm to a person finding themselves in this state of condition, then call Gov. Quinn at 1-217-782-6830 and tell him you are in support of HB 1015 as it stands, if so inclined. Or, if you find this Bill to be offensive or discriminatory, call the number above and tell the Gov. you do not support this Bill and find it punitive and discriminatory, instead of being proactive toward the mentally and chronically ill, if so inclined. HB1015 (225 ILCS 458/1-10) (a) The Department may suspend, revoke, refuse to issue, or renew, or restore a license and may reprimand place on probation or administrative supervision, or take any disciplinary or non-disciplinary action otherwise discipline a licensee, including imposing conditions limiting the scope, nature, or extent of the real estate appraisal practice of a licensee or reducing the appraisal rank of a licensee, and may impose an administrative fine a civil penalty not to exceed \$25,000 for each violation \$10,000 upon a licensee for one or any one or combination of the following: Lines 17 thru 23..... Item.....(20) Habitual or excessive use or addiction to alcohol, narcotics, stimulants, or any other chemical agent or drug that results in a licensee's inability to practice with reasonable judgment, skill, or safety.(21) A physical or mental illness or disability which results in the inability to practice under this Act with reasonable judgment, skill, or safety. if you feel this wording is discriminatory or unfair, then call and vote - no - oppose this bill.
