Re: Comment – Public Hearing on Definition of Fiduciary

Dear Secretary Solis:

We, the undersigned, are members of Primerica's African American Leadership Council and are exclusive representatives of Primerica, Inc.

We are writing to ensure you are aware of the devastating impact the Department of Labor's (DOL) proposed rule change to the definition of a fiduciary would have on middle-income Americans – households with annual income of between \$30,000 and \$100,000 – striving to save through IRAs and on the individuals, such as ourselves, who serve those savers.

Primerica's exclusive representatives assist a largely under-served middle-income market by offering basic investment and savings products. Almost 60% of our accounts are IRAs. Offering Primerica's basic products to families allows us to help them save for their children's education, for retirement, and for their future. We take pride in the opportunity that we have to serve a segment of ordinary households that may not otherwise have access to financial products and services. Most of the homes we visit have unmet needs for financial services, and no one has provided them with any education about the fundamental concepts of saving and investing for the future. One of the most rewarding aspects of our role as Primerica exclusive representatives is that we can introduce these families to the importance of saving for retirement and offer them a vehicle to invest in their futures.

Any change that makes it more difficult for representatives like us to serve middle-income Americans would be devastating to the families that we work with every day. An "advisor model" will not work because the cost of our products and services would increase substantially. Families would have to invest a prohibitively large amount in order to maintain accounts with us – as much as \$25,000, compared to our current small minimum investment. The DOL's proposed rule would force unrealistically high minimum account balances and unaffordable annual service charges, neither of which is practical for our middle-income customers. We anticipate the change would dramatically diminish the demand for IRAs from our middle-income customers. In this economy, people are struggling to save as much as they can to secure an adequate future for themselves. Increasing the cost of saving, and making savings vehicles less accessible to middle-income customers, would truly harm American families and send more and more families into an uncertain financial future.

It has long been a priority of our nation's elected leadership – Democrat and Republican – to encourage more Americans to save for retirement through IRAs. Unfortunately, the DOL's proposed rule changing the definition of fiduciary would run exactly counter to those important efforts.

We believe the DOL should accommodate the needs of different consumer markets. Maintaining the current standard for Broker-Dealers who offer IRAs is essential to the health of retirement savings in this country.

We want to continue helping the families in our communities, and we urge you to lead the Department to avoid enacting a rule that would prevent us from doing so. Thank you for your consideration of our frontline perspective on this vitally important issue, and thank you for your leadership.
