## **DETERMINATION**

Determination of a Complaint Filed under Title IV of the Labor-Management Reporting and Disclosure Act of 1959

On June 19, 2017, the Secretary of Labor received a complaint alleging violations of Section 401 of the Labor-Management Reporting and Disclosure Act of 1959 (LMRDA), in the regularly scheduled election of officers conducted on June 1, 2017, by Roofers Local 22 in Rochester, New York.

Pursuant to Sections 402 and 601 of the LMRDA, the Department of Labor conducted an investigation. The investigation disclosed that Local 22 failed to provide notice of nominations in sufficient time when, after more than six years under trusteeship, it mailed notice of nominations to the membership only 11 days before nominations were due and failed to adequately inform members that nominations could be accepted by fax.

Apprised of these findings, Roofers Local 22 agreed to conduct new nominations and a new election of officers under the supervision of the Secretary of Labor, in accordance with Title IV of the LMRDA. The agreed upon remedial election was concluded on February 9, 2018. It is, therefore,

**DETERMINED**, that there is probable cause to believe that violations of Title IV of the LMRDA occurred which may have affected the outcome of the election conducted by Roofers Local 22 on June 1, 2017, but that these violations have been remedied by the new election, conducted in accordance with Title IV of the LMRDA, under the supervision of the Secretary of Labor, on February 9, 2018.

Therefore, civil action under Section 402(b) of the LMRDA to set aside the election conducted on June 1, 2017 is not warranted.
