#### **DETERMINATION**

Determination of Complaints Filed under Title IV of the Labor-Management Reporting and Disclosure Act of 1959

On August 28, 2017 & December 20, 2017, the Secretary of Labor received complaints alleging violations of Section 401 of the Labor-Management Reporting and Disclosure Act of 1959 (LMRDA), in the regularly scheduled election of officers conducted on August 26, 2017, by Machinists District Lodge 70 in Wichita, Kansas.

Pursuant to Sections 402 and 601 of the LMRDA, the Department of Labor conducted an investigation. The investigation disclosed that Machinists District Lodge 70 failed to provide adequate notice of the election in violation of Section 401(e) when a total of 483 combined nomination/election notices were returned as undeliverable and no attempt was made to obtain current addresses or re-mail the notices. Additionally, the investigation established that employer resources were used to campaign in violation of Section 401(g) when an employer e-mail system was used to disseminate campaign literature by employees who were on employer time.

Apprised of these findings, Machinists District Lodge 70 agreed to conduct a new endorsement vote in Local Lodge 839, and a new election for the offices of President/Directing Business Representative and Secretary Treasurer under the supervision of the Secretary of Labor, in accordance with Title IV of the LMRDA. The agreed upon remedial election was concluded on August 4, 2018. It is, therefore,

<u>DETERMINED</u>, that there is probable cause to believe that violations of Title IV of the LMRDA occurred which may have affected the outcome of the election conducted by Machinists District Lodge 70 on August 26, 2017, but that these violations have been remedied by the new election, conducted in accordance with Title IV of the LMRDA, under the supervision of the Secretary of Labor, on August 4, 2018.

Therefore, civil action under Section 402(b) of the LMRDA to set aside the election conducted on August 26, 2017 is not warranted.
