## **DETERMINATION**

Determination of a Complaint Filed under Title IV of the Labor-Management Reporting and Disclosure Act of 1959

On July 5, 2019, the Secretary of Labor received a complaint alleging violations of Section 401 of the Labor-Management Reporting and Disclosure Act of 1959 (LMRDA), in the regularly scheduled election of officers conducted on December 1, 2017, by International Longshoremen's Association Local 1410 in Mobile, AL.

Pursuant to Sections 402 and 601 of the LMRDA, the Department of Labor conducted an investigation. The investigation disclosed that Longshoremen Local 1410 improperly permitted two ineligible members to vote and denied two eligible members the right to vote, all in violation of Section 401(e) of the LMRDA.

Apprised of these findings, Longshoremen Local 1410 agreed to conduct a new election of trustees under the supervision of the Secretary of Labor, in accordance with Title IV of the LMRDA. The agreed upon remedial election was concluded on September 13, 2019. It is, therefore,

**DETERMINED**, that there is probable cause to believe that violations of Title IV of the LMRDA occurred which may have affected the outcome of the election conducted by International Association of Longshoremen Local 1410 on December 1, 2017, but that these violations have been remedied by the new election, conducted in accordance with Title IV of the LMRDA, under the supervision of the Secretary of Labor, on September 13, 2019.

Therefore, civil action under Section 402(b) of the LMRDA to set aside the election conducted on December 1, 2017 is not warranted.
